Your personal data will be transferred to our IT service providers and partner companies. For the security of your data, an order processing agreement within the meaning of the DSGVO has been concluded with the service providers concerned. Unless otherwise described, your data will not be passed on to third parties.

Member administration

We process the personal data of members so that the idealistic purposes defined in our statutes can be realized in the best possible way: Member administration and maintenance, billing and payment administration of membership fees and networking among members, public relations of the association, photo, video and audio files to fulfill the public relations of the association.

For this purpose, we process the personal data listed on this application plus: Bank and payment data, photo, video and audio files. A further use of these data takes place project-related with the voluntary participation in projects. See the clarification at the projects. We store this data for seven years after termination of membership.

Photo, audio, video files

We regularly take photos, audio recordings and videos at our events, which we may publish on our website, social media and print media as part of our public relations efforts. If you do not wish to be photographed or have been photographed inadvertently, please contact the photographer. The latter will immediately delete the photo taken. For more info, please contact the organizers. These photos may appear on the website for five years and may exist in a print form for up to 14 years.
